Alternate Energy Production Facility Notice Requirement

On January 1, 2013, a notification requirement went into effect. This requirement applies to the owner of an alternate energy production facility which will be attached to an electric transmission or distribution line. Alternate energy production facilities are defined as solar, wind turbine, waste management, resource recovery, refuse-derived fuel, agricultural crops or residues, or wood burning facilities used to generate electricity.

Under this requirement, the owner of the facility is required to provide written notification to their utility of the intent to construct or install the facility at least 30 days prior to construction. In the written notice the owner must provide information on the type of facility and the anticipated completion date of the construction.

Member-owners had questions about tree trimming, safety, security lights, electric vehicles and more. Many wanted to know more about what they have seen in the news about the potential for rolling blackouts this summer and the transition to generation from renewable power resources.

It takes a slow and logical approach to transition electric generation away from fossil fuels in such a way to maintain the affordability and reliability of your power supply. It all boils down to having reliable baseload generation for when renewables aren't available. This is why we call it "all-of-the-above." We will continue to advocate on your behalf for energy strategy on a state and federal level.

I also met last month with RVEC board candidates for the open seat in the district 1, Dave Schroeder and Jim Heithoff. You will find their photos and candidate information on page 3. RVEC member-owners have a say in how their cooperative is run by electing a fellow member-owner to represent them on the board. RVEC has been fortunate over the years having strong leadership at the board level. We expect that to continue with the election this fall.

Fallen Power Line Safety

- Stay far away from fallen power lines and from anything that is touching them. Assume the lines are energized and dangerous.
- Fallen lines are most common after storms and high winds. Debris from a storm can hide fallen power lines. Fallen trees may contain energized power lines.
- Shuffle, don't run, from a fallen power line. Shuffle with your feet together and on the ground. Running or taking large steps can increase the chance that you will be shocked or even killed.
- If a power line falls on your car, stay inside unless the car catches fire. In such a case, jump clear of the car without touching metal and the ground at the same time.

Report outages and hazards!

Call RVEC if your power goes out or you see an electrical hazard such as a downed power line. Our phones are answered 24 hours a day 7 days a week.

Member-owner co-ops rely on people who step up. In the rural area, I believe we are stronger together. I am a proud member-owner of RVEC.

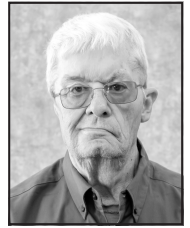
Dave Schroeder

Bus-Stop Safety Reminders

With children heading back to school this month, this is a good time for parents to teach children about school bus safety.

- When waiting for the bus, stay away from traffic and avoid roughhousing.
- Wait for the bus to come to a full stop and its doors to open before stepping off the curb. 28.33.01
- Although other vehicles are required to stop when a school bus does, don't rely on that. When crossing the street in front of a bus, make eye contact with the driver and look all ways at traffic before stepping out.
- Stay in your seat, keep your head, arms and hands inside and keep aisles clear of books and bags.
- Wait for the bus to stop completely before getting up from your seat and leaving the bus.



Spot Your Number

Read Watts Current and watch for your location number. If you spot it, call RVEC by the 20th of the month and you will receive an electrical bill credit for \$25.00.
