

# APPLICATION FOR MEMBERSHIP RACCOON VALLEY ELECTRIC COOPERATIVE

The undersigned hereby applies for membership in Raccoon Valley Electric Cooperative, an Iowa cooperative corporation, hereinafter called the "Association" and agrees, if accepted as a member, as follows:

1. To pay a Meter Deposit fee of \$\_\_\_\_\_. **Waived if we receive a good credit reference from former utility.**
2. To purchase electric service from the Association and to pay therefor monthly not less than the minimum amount at the rates and under the terms established from time to time by the Board of Directors for electric service, beginning with the date of connection of my facilities to the distribution system of the association, and continuing so long as I shall remain a member of the Association.
3. All service lines supplying the undersigned with electric service, and all meters, switches, and other appliances and equipment constructed or installed by the Association in or under the property of the undersigned, except so much, if any, as shall be paid for by me, shall be the sole property of the Association, which shall have the right of access to my premises to repair or service the same, and upon discontinuance of service for any reason, to remove the same.
4. To grant to the Association such easement or easements over my property as shall reasonably be required by the Association to provide electric service to my premises, or the premises of any other member or members of the Association.
5. To comply with and be bound by the provisions of the Articles of Incorporation and by-laws of the Association, and all rules and regulations adopted by its Board of Directors.
6. The Undersigned shall have all the rights and privileges granted to Members under the Articles of Incorporation and by-laws of the Association, and shall be under no personal liability for any of the obligations of the Association.
7. The acceptance of this application by the Board of Directors of the Association shall constitute an Agreement by and between the Association and the undersigned upon the terms hereinabove set forth. The Association agrees to use reasonable diligence in providing a regular and uninterrupted supply of electricity, and shall not be liable in damages to the undersigned for failure temporarily to supply electricity to said premises.
